SUBJECT: Call for Nominations: CAA Board of Directors

The Nominating Committee of the California Apartment Association (CAA) invites nominations for the 2021 Board of Directors, to be submitted by 12:00 noon on Friday, September 18, 2020.

CAA members elect the Board of Directors. Each segment of the membership has representation on the Board, which is comprised of independent rental owners, regional owners and managers, corporate owners, industry partners and regional representatives.

The Nominating Committee invites individuals who have knowledge, skills and experience within the rental housing and apartment industry as well as a track record of community leadership and involvement to place their name into consideration for nomination to the CAA Board of Directors.

Term of Office

Regional Representatives serve a term of two (2) years, all other Directors serve a term of three (3) years. There are twelve (12) open seats for 2021, distributed among the Membership Classifications as follows:

Independent Rental Owners - (0 to 149 Units) - 1 open seat.

Owner/Management Company - (150 to 749 Units) - 1 open seat.

Corporate Members - (750 or more Units) - 5 open seats.

Associate Members - (Industry Partners) - 1 open seat.

Regional Representatives - (Region 1, Region 2, Region 3, Region 4) - 4 open seats.

Region 4: Imperial, Orange, Riverside, San Bernardino and San Diego.

CAA Board Nomination Schedule

Completed applications are due by 12:00 noon on September 18, 2020. The Nominating Committee will recommend a slate of Director nominees to the membership on or about September 23, 2020.

The CAA Board of Directors' election will open on or about October 23, 2020. Voting will close on October 29, 2020. The 2021 CAA Board of Directors will be announced to the CAA Membership on or about October 30, 2020.
